TCS on Forex Transactions - An Update

From 1 July 2021, TCS is applicable on all forex transactions that include transfers made for the purpose of

- Application fees
- Acceptance Deposits
- Tuition Fees
- GIC / Blocked Account Transfer / FTS
- Accommodation
- Living expenses

Further, from 1st July 2021 TCS/TDS would be collected /deducted at higher Rate for Specified persons. The definition of Specified person and the rate is as below

Specified Person - means “a person who has not filed the returns of income for both of the two assessment years relevant to the two previous years immediately prior to the previous year in which tax is required to be deducted, for which the time limit of filing return of income under sub-section (1) of section 139 has expired; and the aggregate of tax deducted at source and tax collected at source in his case is rupees fifty thousand or more in each of these two previous years”.

Rate for Specified Person - In case of Specified person, TCS is applicable @ 10% instead of 5% (for education loan cases @ 5% instead of 0.5%).

This tax paid can be set-off against your overall tax liability and excess claimed as tax-refund.

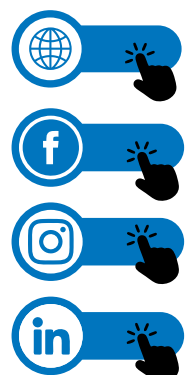

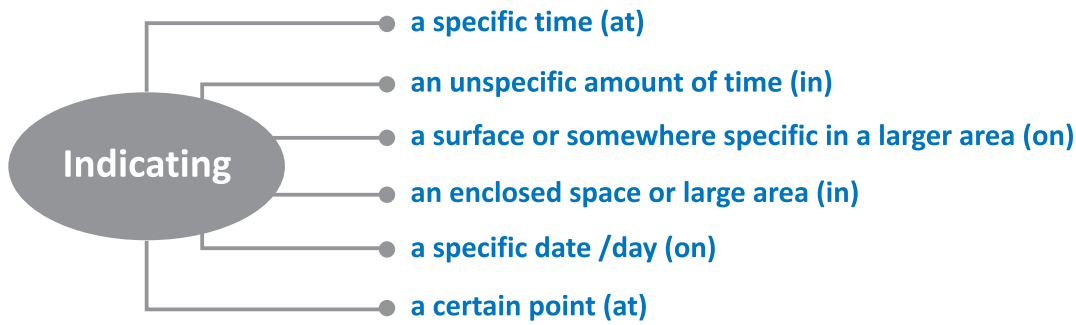
